

AN ORDINANCE 2010-04-15-0315

AUTHORIZING THE EXECUTION OF AN AGREEMENT TRANSFERRING ALL OBLIGATIONS AND LIABILITIES OF THE PROFESSIONAL SERVICES AGREEMENT WITH DMJM AVIATION, INC. TO AECOM TECHNICAL SERVICES, INC. FOR ENGINEERING SERVICES ASSOCIATED WITH THE RUNWAY 3/21 EXTENSION, TAXIWAY RC EXTENSION AND AIRFIELD PAVEMENT REPAIRS AT SAN ANTONIO INTERNATIONAL AIRPORT.

WHEREAS, the City of San Antonio (the "City") entered into a Professional Services Agreement with DMJM Aviation, Inc. ("DMJM") for design and construction services for the Runway 3-21 Extension, Taxiway RC Extension, and Airfield Pavement Repair Projects (herein called the "Original Agreement") as authorized by Ordinance No. 2008-06-05-0469 on June 5, 2008; and

WHEREAS, DMJM has merged with AECOM Technical Services, Inc. and AECOM Technical Services, Inc. has assumed all obligations and liabilities of the Original Agreement, as amended, by executing the Transfer Agreement (Novation Agreement) attached hereto as Attachment I; and

WHEREAS, it is necessary for the City to execute the Transfer Agreement to complete the transfer of all obligations and liabilities of the Original Agreement to AECOM Technical Services, Inc.; and

WHEREAS, it is necessary to authorize the execution of the Transfer Agreement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is authorized to execute the attached Transfer Agreement transferring all obligations and liabilities of the Original Agreement with DMJM Aviation, Inc. to AECOM Technical Services, Inc. for engineering services associated with the Runway 3/21 Extension, Taxiway RC Extension and Airfield Pavement Repairs at San Antonio International Airport.

SECTION 2. This Ordinance shall take effect immediately upon passage by eight (8) affirmative votes; otherwise it shall be effective ten (10) days after its passage.


