

AN ORDINANCE **2011-06-17-0529**

CANVASSING THE RESULTS OF THE RUN-OFF ELECTION HELD ON SATURDAY, JUNE 11, 2011.

* * * * *

WHEREAS, a Run-off Election was held on Saturday, June 11, 2011, for the purpose of electing City Council Members for Districts 1 and 7; and

WHEREAS, it is now necessary to canvass the returns of the Run-off Election; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council, having convened on this 17th day of June, 2011, to canvass the returns of the Run-off Election held on June 11, 2011, and after canvassing the returns of this election, officially finds and determines that this election was duly ordered; proper notice of this election was given; proper election officers were duly appointed prior to this election; the election was duly held; the City has complied with the Federal Voting Rights Act, the Texas Election Code, and the City Charter; and due returns of the result of this election have been made and delivered, all in accordance with the law and the Ordinance calling the Run-off Election.

SECTION 2. The City Council does officially find and declare the results of the Run-off Election to be as follows:

SECTION 3. As a result of the Run-off Election held on June 11, 2011, the following individuals were elected Council Members for a two-year term commencing June 17, 2011:


Diego Bernal	Member of Council	Place No. 1




