

AN ORDINANCE      2011-12-15-1070

**RECOMMENDING THE DISANNEXATION OF APPROXIMATELY 22.86 ACRES OF LAND GENERALLY LOCATED NEAR THE INTERSECTION OF IH35 AND LOOP 1604 AND SOUTH OF THE MEDINA RIVER, IN SOUTHWEST BEXAR COUNTY, FROM THE CITY SOUTH MANAGEMENT AUTHORITY.**

**WHEREAS**, on September 1, 2011, the City of San Antonio released approximately 2,717 acres (4.12 square miles) from the extraterritorial jurisdiction (ETJ) of the City of San Antonio; and

**WHEREAS**, it is the desire of Von Ormy to gain this area; and establish a half (½) mile ETJ around Von Ormy's city limits; and

**WHEREAS**, 22.86 acres of land generally located near the intersection of I-35 South and Loop 1604, south of the Medina River, are within the City of Von Ormy or its ETJ, and the City South Management Authority; and

**WHEREAS**, the City South Management Authority held two public hearings on October 13 and November 10, 2011, has considered the proposed disannexation of the property from the City South Management Authority and has recommended approval, **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The property containing approximately 22.86 acres as more particularly described in Attachment 1, attached hereto and incorporated herein for all purposes, is hereby disannexed from the City South Management Authority.

**SECTION 2.** This ordinance shall take effect December 15, 2011.


