

AN ORDINANCE 2010-12-16-1090

APPOINTING 14 MEMBERS TO THE CITIZEN
ADVISORY ACTION BOARD (CAAB).

WHEREAS, pursuant to the provisions of Section 3 of Article 9 of the Collective Bargaining Agreement between the City of San Antonio, Texas and the San Antonio Police Officers' Association (CBA) executed on July 2, 2010, the San Antonio City Council must select fourteen persons from a list of applicants provided by the City Manager to serve as members of the Citizen Advisory Action Board for two-year terms; and

WHEREAS, the City Manager and the Chief of Police must determine whether the persons on the list should be recommended; and

WHEREAS, the San Antonio Police Officers' Association must determine whether the persons on the list should be recommended; and

WHEREAS, the list must be representative of the diversity of the community; and

WHEREAS, those on said list must meet the minimum qualifications established by Subsection 143.006(c) of the Texas Local Government Code for service on the San Antonio Fire Fighters' and Police Officers' Civil Service Commission; and

WHEREAS, the City Manager submitted such a list and all of those on that list meet the minimum qualifications; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following persons are hereby selected and appointed to serve as members of the Citizens Advisory Action Board (CAAB):

SECTION 2. Said members service on the CAAB shall begin on December 16, 2010, and end on December 15, 2012.






