AN ORDINANCE (1292)

APPROPRIATING \$400,569.92 OUT OF 1941 GENERAL FUND TO PAY 1941

GENERAL FUND NOTES NOS. 72 TO 87 INCLUSIVE, AND ACCRUED INTEREST

BE IT ORDAINED by the Commissioners of the City of San Antonio, that, the sum of \$400,000.00, be and the same is appropriated hereby out of 1941 General Fund (Various Departments) payable to Frost National Bank of San Antonio, Texas, to pay sixteen (16) Notes Nos. 72 to 87 inclusive of the 1941 General Fund Series, \$25,000.00 each, maturing on or before July 1, 1942;

AND, the sum of \$569.92, be and the same is appropriated hereby out of 1941 General Fund (Interest Department) to pay accrued interest on 1941 General Fund Notes Nos. 72 to 87 inclusive.
