

AN ORDINANCE **97165**

**APPOINTING A REPLACEMENT FOR THE CITY  
COUNCIL DISTRICT 5 VACANCY AND PROVIDING  
FOR AN IMMEDIATE EFFECTIVE DATE UPON  
PASSAGE OF EIGHT (8) AFFIRMATIVE VOTES.**

*WHEREAS*, Councilman David Garcia, District 5 representative on the City Council, has submitted his resignation effective January 16, 2003; and

*WHEREAS*, pursuant to the City of San Antonio City Charter, Section 8, a vacancy on the Council is to be filled by a majority vote of the remaining members for the unexpired term; and

*WHEREAS*, the City Council invited the qualified residents of District 5 to submit applications and letters of interest to the City Clerk's Office for consideration for appointment to fill the District 5 vacancy; and

*WHEREAS*, on January 30, 2003, the City Council interviewed nine (9) qualified candidates and submitted the following nominations: Ms. Dora Ramos, Mr. Ralph T. Gomez, and Ms. Nora X. Herrera; and

*WHEREAS*, the City Council of the City of San Antonio now wishes to appoint a replacement to fill the unexpired City Council term of David Garcia, District 5; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

*SECTION 1.* Nora X. Herrera is hereby appointed as a member of the City Council, Place No. 5, to serve for the remainder of the unexpired term of David Garcia, which term shall be through May 31, 2003.

*SECTION 2.* Because the citizens of District 5 should not be without representation on the City Council, the City Council deems an emergency exists, making it necessary to provide for an immediate effective date upon passage by eight (8) affirmative votes; otherwise, said effective date shall be ten (10) days from the date of passage hereof.


SUBJECT: Ordinance appointing replacement for City Council, District 5

DATE: January 31, 2003

This Ordinance will appoint a replacement to fill the unexpired term of Councilman David Garcia, whose term of office will run through May 31, 2003 shall be placed on the City Council agenda of February 6, 2003.

Councilman David Garcia submitted his resignation as the Councilman for District 5 on Thursday, January 16, 2003, and the City Council officially accepted his resignation by Ordinance on January 23, 2003. In accordance with the City Charter, the vacancy shall be filled by a majority vote of the remaining members of the Council. As directed by City Council, the City Clerk's Office began the advertisement on Friday January 17, 2003 to solicit applications from interested citizens wishing to fill the vacancy with the deadline for submission on Tuesday, January 28, 2003.

Nine (9) qualified candidates submitted their letters of interest. Interviews of the candidates were conducted on Thursday, January 30, 2003. The following nominations have been submitted by the City Council: Ms. Dora Ramos, Mr. Ralph T. Gomez, and Ms. Nora X. Herrera. A public meeting was held on Monday, February 3, 2003 at the Bazan Library where citizens of District 5 had the opportunity to meet and direct comments/questions to the three candidates. The final selection for the District 5 replacement is scheduled for Thursday, February 6, 2003. Letters of interest with resumes for the three candidates are attached for your reference.
