

AN ORDINANCE 2014 - 10 - 02 - 0747

AUTHORIZING THE STREET NAME CHANGE OF "CANTRELL DRIVE" TO "FELIX TREVINO WAY" BETWEEN SOUTH ZARZAMORA STREET AND DELIGHT STREET, IN CITY COUNCIL DISTRICT 4, SAN ANTONIO, TEXAS.

WHEREAS, the Development Services Department received an application request from Park South Village, Inc. to rename a section of Cantrell Drive between the cross streets of South Zarzamora Street and Delight Street first, to eliminate any safety concerns with two streets named Cantrell Drive (see attachment 1) and second, as a lasting memorial to Felix B. Trevino to honor his long time contributions to the community, specifically his more than 50 years of service on the Board of Directors of the Park South Village, Inc.; and

WHEREAS, the Development Services Department staff was tasked with implementing this request through the street naming process as required by Chapter 6 of the City Code; and

WHEREAS, this request was forwarded to and reviewed by all City of San Antonio departments and outside agencies and no opposition was identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for naming of public streets; and

WHEREAS, notice of this request to rename said street was properly posted and mailed to affected property owners, notice requirements for renaming of the street has been satisfied in accordance with Chapter 6 of the City Code and further, no written opposition has been received to the name change from affected property owners; and

WHEREAS, a public hearing before the Planning Commission was held on August 27, 2014 allowing all interested persons to be heard; and

WHEREAS, the Planning Commission approved a motion to support the street name to Felix Trevino Way; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1 Cantrell Drive in City Council District 4 between South Zarzamora Street and Delight Street is hereby named Felix Trevino Way. The location is more specifically depicted in Attachment 2. City staff is directed to provide appropriate signage to this effect.

SECTION 3. This ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.




