

AN ORDINANCE **2007-02-15-0172**

AUTHORIZING EXECUTION OF A CONTRACT CHANGE WITH THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES TOTALING \$147,294.00 WHICH WILL PROVIDE ADDITIONAL SUPPORT FOR THE ONGOING INNER-CITY SCHOOL IMMUNIZATION PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT BY INCREASING THE CURRENT CONTRACT FROM \$429,812.00 TO \$577,106.00 FOR THE PERIOD SEPTEMBER 1, 2006 THROUGH AUGUST 31, 2007; AND REVISING THE PROGRAM BUDGET AND PERSONNEL COMPLEMENT.

WHEREAS, the City Manager was authorized to execute a contract with the Texas Department of State Health Services (TDSHS) which provides assistance to the City of San Antonio in support of core public health activities offered by the San Antonio Metropolitan Health District (SAMHD); and

WHEREAS, the Inner-City School Immunization Program of the SAMHD works to eliminate barriers, expand immunization delivery, and establish consistent policies to immunize pre-school age children; and

WHEREAS, contract changes are made throughout the term of the contract in order to renew grant programs when their terms expire; and

WHEREAS, the TDSHS has now offered a contract change totaling \$147,294.00 to augment support for the ongoing Inner-City School Immunization Program of the San Antonio Metropolitan Health District for the period September 1, 2006 through August 31, 2007; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is authorized to execute a contract change with the Texas Department of State Health Services (TDSHS) totaling \$147,294.00 which will provide additional support for the ongoing Inner-City School Immunization Program of the San Antonio Metropolitan Health District by increasing the current contract from \$429,812.00 to \$577,106.00 for the period September 1, 2006 through August 31, 2007. A copy of said contract change is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. Fund 26016000 entitled "Texas Department of State Health Services" and Internal Order 13600000333 entitled "Inner-City School Immunization 2006-07", are hereby designated for use in the accounting for the fiscal transaction in the amending of the Funding Agreement with the TDSHS.

SECTION 3. The additional sum of \$147,294.00 is hereby appropriated in the above designated fund and the revised budget which is attached hereto and incorporated herein for all purposes as Attachment II is approved and adopted for entry on the City books.

SECTION 4. The revised personnel complement which is attached hereto and incorporated herein for all purposes as Attachment II is approved.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 6. This ordinance shall be effective on and after February 25, 2007.


