

AN ORDINANCE 82320

DESIGNATING CERTAIN MEMBERS OF THE COUNCIL AS MAYOR PRO TEM FOR SPECIFIED PERIODS OF TIME THROUGH MAY 31, 1997.

WHEREAS, the City Charter in Section 9 calls for a Mayor Pro Tem to act as Mayor during the absence or disability of the Mayor; and

WHEREAS, a tradition has been established of rotating the Mayor Pro Tem position among all of the members of the Council other than the Mayor during each two year term; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following named members of the City Council are hereby designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:

SECTION 2. Should any of the above Council Members be replaced for any reason, such replacement shall be substituted for such member for the term indicated.

SECTION 3. Because of the necessity of having a Mayor Pro Tem to act in the absence of the Mayor, an emergency is hereby declared so that upon receipt of eight affirmative votes, this ordinance shall take effect immediately upon passage.
