

AN ORDINANCE 2007 - 02 - 08 - 0141

AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS IN AN AMOUNT NOT TO EXCEED \$2,000.00 FROM THE NATIONAL DISABILITY INSTITUTE FOR THE 2007 REAL ECONOMIC IMPACT TOUR IN SAN ANTONIO TO PROMOTE AWARENESS OF FREE TAX PREPARATION SERVICES AND ASSET-BUILDING PROGRAMS FOR WORKING FAMILIES WITH DISABILITIES; AUTHORIZING THE EXECUTION OF RELATED CONTRACTS; APPROPRIATING FUNDS; AND APPROVING A BUDGET.

WHEREAS, the City of San Antonio's Department of Community Initiatives' Family Economic Success Program promotes debt reduction, asset building, asset protection, and other family strengthening strategies designed to assist families in meeting basic daily living needs, save for the future and avoid excessive indebtedness; and

WHEREAS, The National Disability Institute has awarded the City of San Antonio a grant to promote awareness of tax and asset-building programs for working families with disabilities; and

WHEREAS, the Department of Community Initiatives (DCI) formed a collaborative group with many service providers to inform the disabled community of the many opportunities that are available to assist them in the effort to improve their family economic situation; and

WHEREAS, the collaborative group proposes to host its Real Economic Impact (REI) awareness event to outreach to the disabled community as part of the 2007 REI Tour, which is scheduled for 54 cities, including San Antonio; and

WHEREAS, the DCI wishes to accept the \$2,000.00 grant from the National Disability Institute to host the REI awareness event so as to promote awareness of free tax preparation services offered through the Volunteer Income Tax Assistance (VITA) program, as well as all other asset building programs offered by DCI and numerous other service providers; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, or the Director of the Department of Community Initiatives, or his designee, is authorized to accept a grant in the amount of \$2,000.00 from the National Disability Institute to host the Real Economic Impact (REI) awareness event so as to promote awareness of free tax preparation services offered through the Volunteer Income Tax Assistance (VITA) program, as well as all other asset building programs offered by the Department of Community Initiatives (DCI) and numerous other service providers.

SECTION 2. Fund 26012000 and Internal Order 138000000546 entitled “National Disability Institute 2007”, are hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant.

SECTION 3. The sum of \$2,000.00 is hereby appropriated in the above designated fund and will be disbursed from GL 5201040 entitled “Fees to Professional Contractors”.

SECTION 4. The budget, which is attached hereto and incorporated herein for all purposes as Attachment I, is approved and adopted for entry in the City books.

SECTION 5. The City Manager, or her designee, or the Director of the Department of Community Initiatives, or his designee, is authorized to execute any related contracts in connection with the acceptance of this grant.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 7. This ordinance shall be effective on and after February 18, 2007.
