

AN ORDINANCE

2014-12-04-0972

**DIRECTING THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT TO INITIATE LIMITED PURPOSE ANNEXATION AND PREPARE A REGULATORY PLAN FOR FIVE ANNEXATION PRIORITY AREAS IN 2015 AND 2016, WHICH ARE CONTIGUOUS TO THE CITY LIMITS AND WITHIN THE SAN ANTONIO EXTRATERRITORIAL JURISDICTION AND BEXAR COUNTY.**

**WHEREAS**, on February 14, 2013, City Council adopted the City of San Antonio Annexation Policy that provides guidance and rationale for the consideration of areas within the City of San Antonio's extraterritorial jurisdiction (ETJ) for annexation; and

**WHEREAS**, on November 12, 2014, City Council was briefed on five propriety areas proposed for annexation in 2015 and 2016 which are identified in Attachment I; and

**WHEREAS**, the proposed priority annexation areas were evaluated based on policies and criteria in the adopted City of San Antonio Annexation Policy; and

**WHEREAS**, this request for annexation is consistent with the City of San Antonio Annexation Policy, adopted February 14, 2013, which San Antonio recommends annexation of areas to promote economic growth, facility long-range planning, protect future development, and foster intergovernmental relations; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Council hereby directs the Department of Planning and Community Development to initiate limited purpose annexation and prepare a regulatory plan for five annexation priority areas in 2015 and 2016, which are contiguous to the City limits and within the San Antonio Extraterritorial Jurisdiction (ETJ) and Bexar County. The subject annexation areas are identified in Attachment I, which is attached hereto and is made part of this Ordinance for all purposes.

**SECTION 2.** This ordinance shall be effective on December 4, 2014.


