

AN ORDINANCE 2012 - 11 - 08 - 0880

**AUTHORIZING THE EXECUTION OF A RENEWAL AGREEMENT
FOR FEDERAL REPRESENTATION SERVICES WITH PATTON
BOGGS, LLP FOR A TOTAL MONTHLY AMOUNT OF \$16,666.00
BEGINNING JANUARY 1, 2013 AND ENDING DECEMBER 31, 2013.**

WHEREAS, on April 8, 2010, City Council authorized the execution of Professional Services Agreement for Federal Representation Services (“Agreement”) with Patton Boggs, L.L.P. (“Patton Boggs”) through September 30, 2011, with two additional one-year renewal periods; and

WHEREAS, City Council later authorized the execution of the First Amendment and Renewal Agreement with Patton Boggs extending the Agreement through December 31, 2012; and

WHEREAS, City staff recommends exercising the final available renewal period extending the Agreement through December 31, 2013; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of the Renewal Agreement to the Professional Services Agreement for Federal Representation Services are authorized and approved. The City Manager, or her designee, is authorized to execute the Renewal Agreement. A copy of the Renewal Agreement, in substantially final form, is attached to this Ordinance as **Exhibit I**.

SECTION 2. Funding in the amount of \$149,994.00 for this Ordinance is available in Fund 11001000, Cost Center 0801010001 and General Ledger 5201040, as part of the Fiscal Year 2013 Budget.

SECTION 3. Funding in the amount of \$49,998.00 for this Ordinance as part of the Fiscal Year 2014 Budget is contingent upon City Council approval of the City’s operating budget and the availability of funds.

SECTION 4. Payment not to exceed the budgeted amount is authorized to Patton Boggs, LLP and shall be encumbered with a purchase order. All expenditures will comply with the approved operating budget for current and future fiscal years.




SECTION 6. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.







**RENEWAL AGREEMENT TO PROFESSIONAL
SERVICES AGREEMENT FOR FEDERAL REPRESENTATION SERVICES**

FOR VALUE RECEIVED, the receipt and sufficiency of which is hereby acknowledged, this Renewal Agreement to the Professional Services Agreement for Federal Representation Services ("Renewal Agreement") is entered into by the CITY OF SAN ANTONIO, a Texas Municipal corporation ("CITY"), acting by and through its City Manager pursuant to and duly authorized by Ordinance No. 2012-11-08-____, passed and approved on November 8, 2012, and Patton Boggs, L.L.P. ("CONSULTANT") acting by and through its duly authorized designated officer.

WHEREAS, CITY and CONSULTANT entered into the Professional Services Agreement for Federal Representation Services ("Agreement") pursuant to City of San Antonio Ordinance No. 2010-04-08-309 dated April 8, 2010, which was subsequently amended and renewed by the First Amendment and Renewal Agreement pursuant to City of San Antonio Ordinance No. 2011-06-16-0513 dated June 16, 2011; and

WHEREAS, under Section 2.2 of the Agreement, the Agreement may be renewed for two additional one-year terms in the sole discretion of CITY, subject to City Council approval; **NOW THEREFORE:**

- A. CITY and CONSULTANT exercise the second available renewal option provided for under Section 2.2 and extend this Agreement through December 31, 2013.**

Except as otherwise expressly modified hereby, all terms and provisions of the Agreement are ratified and confirmed and shall remain in full force and effect, enforceable in accordance with their terms.
