

AN ORDINANCE 2014 - 05 - 15 - 0350

**AUTHORIZING THE RENAMING OF “CLASSEN ROAD” TO
“CLASSEN SPUR” BETWEEN THE NEW ALIGNMENT OF CLASSEN
ROAD AND BULVERDE ROAD LOCATED IN CITY COUNCIL
DISTRICT 10, SAN ANTONIO, TEXAS.**

WHEREAS, Jack Braha is requesting a street name change for a portion of Classen Road, as the road is in the process of being realigned per the City of San Antonio Major Thoroughfare Plan to intersect Bulverde Road at +/- 800 feet south of the current intersection; and

WHEREAS, once aligned, there will be duplicate streets named Classen Road within the City municipal boundary; and

WHEREAS, duplicate street names create conflict when assigning addresses within the area, and presents safety concerns in the event emergency services are unable to locate the correct property in a timely manner. The street name change will simplify the traffic patterns, enhance public safety, improve emergency response times, and minimize public confusion; and

WHEREAS, the realignment necessitates the renaming of approximately one thousand two hundred (1,200) linear feet of street between Bulverde Road and Classen Road; and

WHEREAS, Chapter 6 of the City Code of San Antonio, Texas, authorizes and provides a process to rename streets; and

WHEREAS, as part of that process, this request was forwarded to and reviewed by applicable City of San Antonio departments and outside agencies and approved; and

WHEREAS, notice of this request to rename said street was properly posted at City Hall, notice was mailed to affected property owners, and notice was disseminated through public service announcements, the notice requirements for renaming streets have been satisfied and further, no written opposition has been received to the name change from property owners; and

WHEREAS, a public hearing before the Planning Commission was held on April 9, 2014, allowing all interested persons to be heard; and

WHEREAS, the Planning Commission thereafter approved a motion to support the street name change of “Classen Road” to “Classen Spur”; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The city-owned street known as “Classen Road” located in City Council District 10 between the new alignment of “Classen Road” and Bulverde Road as graphically depicted in

Exhibit 1 is hereby renamed "Classen Spur." City staff is directed to provide appropriate signage to this effect. A graphic is attached as Exhibit 2 detailing the location of the street impacted.

SECTION 2. Funds generated by this ordinance will be deposited as per the table below:

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance becomes effective immediately upon receipt of eight affirmative votes; otherwise, it is effective ten days after passage.




