

NOVEMBER 23, 1945

REGULAR MEETING OF THE COMMISSIONERS OF THE CITY OF SAN ANTONIO, HELD IN THE COUNCIL CHAMBER OF THE CITY HALL, AT TEN O'CLOCK, A.M., ON FRIDAY, NOVEMBER 23, 1945.

(Thursday, November 22, 1945, Thanksgiving Day, having been a legal holiday, the regular meeting passed automatically to the following day, as provided in the Rules of Procedure of the Board of Commissioners.)

PRESENT: Mauermann, Callaghan, Hein, Steffler, Anderson; Mayor Mauermann presiding.

The Clerk read the minutes of the Regular Meeting of November 15, together with those of the Recessed Meeting of November 20, which minutes were approved as read, on motion of Commissioner Steffler, seconded by Commissioner Hein and carried by roll call vote, to-wit: Ayes, Mauermann, Callaghan, Hein, Steffler and Anderson.
