

AN ORDINANCE 2012-12-13-0999

DECLARING AS SURPLUS AND AUTHORIZING THE DISPOSITION OF AN APPROXIMATE 0.6767 ACRE TRACT OF LAND LOCATED AT 3185 CENIZO WITHIN COUNTY BLOCK 4010C, LOCATED WITHIN THE EXTRA-TERRITORIAL JURISDICTION LINE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following property, held by the City of San Antonio for the use, benefit and control of the San Antonio Water System, (formerly BexarMet), is declared surplus to the needs of the City of San Antonio:

Being a 0.6767 acre tract out of Lot 23, Block 2, County Block 4167, Bluebonnet Ridge Estates Subdivision, Unit 3, Bexar County, the tract being known as the Water-Well-Site Tract and located generally on **Attachment I** and described in detail on **Attachment II**.

SECTION 2. The President/CEO of the San Antonio Water System and his designee(s), severally, are authorized to do all things necessary or convenient to advertise the property for sale according to law, accept such bid as the San Antonio Water System may in its discretion accept (without requiring the San Antonio Water System to accept any bid), and effectuate transfer of the City's title to the property to the successful bidder.

SECTION 3. Funds generated by this ordinance will be for the use, benefit and account of the San Antonio Water System.

SECTION 4. This ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.






