

AN ORDINANCE 2012-06-07-0407

APPOINTING KAUSI S. SUBRAMANIAM AND LARRY S. ANTHIS AS AT-LARGE, BUSINESS COMMUNITY/CHAMBER REPRESENTATIVES, AND CHAD D. TAYLOR AS AN AT-LARGE, GENERAL COMMUNITY REPRESENTATIVE, TO THE CONVENTION AND VISITORS COMMISSION FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MAY 31, 2013; AND WAIVING THE CITY CODE RESIDENCY REQUIREMENT IN CHAPTER 2, ARTICLE IX, SEC. 2-529(B) FOR MS. SUBRAMANIAM'S APPOINTMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Kausi S. Subramaniam and Larry S. Anthis are appointed as At-Large, Business Community/Chamber Representatives, and Chad D. Taylor is appointed as an At-Large, General Community Representative, to the Convention and Visitors Commission for the remainder of unexpired terms of office to expire May 31, 2013.

SECTION 2. The City Code residency requirement in Chapter 2, Article IX, Sec. 2-529(b) is waived for Ms. Subramaniam's appointment.

SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes, or, in the event eight affirmative votes are not received, ten days after passage.






