

AN ORDINANCE 2014 - 11 - 18 - 0 936

AUTHORIZING AN AMENDMENT TO THE SPORTS LICENSE AGREEMENT WITH SA FIVE DIAMONDS LITTLE LEAGUE, INC. TO EXPAND THEIR LICENSE AGREEMENT AREA FOR ADDITIONAL YOUTH SPORTS RECREATION AMENITIES AT STINSON PARK, LOCATED IN COUNCIL DISTRICT 3.

WHEREAS, the SA Five Diamonds Little League, Inc. (League) has had a presence at Stinson Park since the 1990s; and

WHEREAS, the City of San Antonio renewed the sports license agreement with the League on June 1, 2013, for the use of five (5) sports fields located at Stinson Park; and

WHEREAS, this allowed the League to continue providing sports activities to area youth on a year-round basis; and

WHEREAS, the League maintains more than eighty-five (85) youth sports league teams and divisions within its current footprint at Stinson Park, serving more than 6,500 children ages three (3) to eighteen (18) through fall, summer, and spring season programming; and

WHEREAS, Toyota Motor Manufacturing Texas, Inc. has supported the League since 2010, providing seed money for a new scoreboard and the League's message board for parents to access League information; and

WHEREAS, the League received a \$200,000.00 donation from Toyota Motor Manufacturing Texas, Inc. in the spring of 2014, for the construction of a new sports field at Stinson Park, which will serve an additional 1,700 children; and

WHEREAS, construction of new youth sports amenities will allow the organization to activate a portion of the park that is currently dormant; and

WHEREAS, additionally, the expanded area will increase League enrollment, enhance service delivery across all fields, and allow the organization to offer programming for increased skill levels for existing youth participants; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the Parks and Recreation Department or his designee, is authorized to execute an amendment to the sports license agreement with SA Five Diamonds Little League, Inc. to expand their license agreement area for additional youth sports recreation amenities at Stinson Park, located in Council District 3. A copy of the amendment in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.



AMENDMENT #1 TO LICENSE AGREEMENT

SA FIVE DIAMONDS LITTLE LEAGUE, INC.

This Amendment #1 to the Sports License Agreement for the SA Five Diamonds Little League, Inc. is made by and through the CITY OF SAN ANTONIO, a Texas municipal corporation ("City"), acting by and through its City Manager or her designee, pursuant to Ordinance No.2013-05-09-0325, passed and approved on May 9, 2013, and SA Five Diamonds Little League, Inc. ("League").

WHEREAS, City and SA Five Diamonds entered into a License Agreement for League to have priority use of five fields at Stinson Park in exchange for maintenance of the park, and

WHEREAS, City and League wish to expand the licensed area for additional sports recreation amenities for use by SA Five Diamonds at Stinson Park,

NOW THEREFORE, The City and SA Five Diamonds hereby agree to amend the agreement as follows:

Section 2.1 is hereby amended to include the Premises outlined in Exhibit A-1, which is added to the original license agreement for the purpose of additional sports recreation amenities. The League will be responsible for all construction, repair and on-going maintenance of such improvements. Exhibit A-1 shall be updated following the construction of the proposed improvements to more clearly indicate the Premises.

All other terms of the original License Agreement shall stand as otherwise stated.
