BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following named members of the City Council are hereby designated as Mayor Pro-Tem of the City of San Antonio to serve during the periods indicated:

SECTION 3. Because of the necessity of having a Mayor Pro-Tem to act in the absence of the Mayor, an emergency is hereby declared so that upon receipt of eight affirmative votes this ordinance shall take effect immediately upon passage.
