

AN ORDINANCE **84245**

AMENDING ORDINANCE NO 81513 TO REFLECT PRECINCT  
CHANGES AND UPDATES TO BE USED IN THE MAY 3, 1997,  
REGULAR CITY ELECTION

**WHEREAS**, by Ordinance No 81513 of January 19, 1995, the City amended, revised and established its voting precincts, and

**WHEREAS**, the precincts as established therein were used for the May 6, 1995, Regular Election, and

**WHEREAS**, due to annexations made by the City of San Antonio effective December 31, 1995, and the incorporation of these annexations into new and split precincts approved by the Bexar County Commissioners' Court, it is necessary to amend Ordinance 81513 to reflect changes to the precincts for use in the May 3, 1997, election; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** That Ordinance 81513 of January 19, 1995, which established voting precincts for the City, is amended to conform with the precinct listing as shown on the listing attached hereto and incorporated herein for all purposes. These precincts are shown on the map on file in the office of the City Clerk, describing and depicting City Voting precincts; Such map is hereby adopted and incorporated herein by reference


**SECTION 2.** The revised precincts shall be used for the May 3, 1997, Regular Election

The precincts allocated by City Council Districts are listed by three categories: Total Precincts, Split Precincts, and Precincts that are in the Right-of-Way of roadways. The types of precincts are defined as:

TOTAL PRECINCT - The entire precinct is geographically located within the City Council District and all the residents are represented by the elected Council Person of that District.

SPLIT PRECINCT (\*SPLIT) - A precinct that is not totally in the City Limits of San Antonio. Parts of the precinct may be shared by other communities or unincorporated Bexar County. These may include right-of-way and parts of the City.

RIGHT-OF-WAY (\*\*ROW) - These are precincts which are City Limit extensions of major highways and roads due to annexations. Only the Right-of-Way is in the City Limits and does not have any residents.

SUMMARY:
