AN ORDINANCE **77860**

DECLARING THE RESULTS OF THE CANVASS OF THE MUNICIPAL ELECTION HELD THE 1ST DAY OF MAY, 1993.

WHEREAS, the regular municipal election was held on the 1st day of May, 1993, to determine the Mayor and Council Members of the City of San Antonio for the ensuing term of office of two years; and

WHEREAS, the names of the candidates were submitted, the election was held and conducted and the returns thereof were made, all as required by the City Charter and the laws of the State of Texas; and

WHEREAS, the City Council met on May 4, 1993, to canvass the returns of the said election; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council having convened May 4, 1993, to canvass the returns of the regular City election held May 1, 1993, after canvassing the returns of said election, does hereby find and declare the result of the election to be as follows:

and each of them was elected by receiving a majority of all the votes cast for the office for which each was a candidate cast by the qualified voters of the City of San Antonio voting at said election, and they and each of them are hereby declared to be the lawful and duly elected Council Member of the City for the places specified.

SECTION 3. It is further declared that as a result of said election, no candidate for Place No. 7, received a majority of all the votes cast by the qualified voters of the City voting in said election, therefore, no candidate was elected at said election for the office of Member of Council for Place 7, but that a second or run-off election will be necessary in order that the candidate receiving the highest number of votes shall have received a majority of all the votes cast for the office. The two candidates receiving the highest number of votes for such place in the election shall again be voted for at the second or run-off election, to be called by separate ordinance:


