AN ORDINANCE

AMENDING ORDINANCE NO. 32375, PASSED AND APPROVED ON JUNE 11TH, 1964, BY APPROPRIATING THE SUM OF \$75,000, INSTEAD OF \$57,000 ORIGINALLY APPROPRIATED; AND AUTHORIZING THE TRANSFER OF \$18,000 FROM THE GENERAL FUND CONTINGENCY ACCOUNT 70-01-01 TO THE COMMUNITY AND CONVENTION CENTER BOND FUND NO. 489-05, PAYABLE TO NOONAN & KROCKER AND PHELPS & SIMMONS & ASSOCIATES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 32375, passed and approved on June 11th, 1964, is hereby amended by increasing the appropriation to \$75,000 from the \$57,000 originally appropriated; and authorizing the transfer of \$18,000 from the General Fund Contingency Account 70-01-01 to the Community and Convention Center Bond Fund No. 489-05, payable to Noonan & Krocker and Phelps, Simmons & Associates.


SUBJECT: Appropriating Ordinance for Architectural Fees on Community and Convention Center.
