When the following proceedings were had, to-wit:

In the matter of the awarding of the contract for the construction of the Robert B. Green, Memorial Hospital.

Upon the motion of the Honorable Clinton G. Brown, Mayor of the City of San Antonio, seconded by the Honorable Jacob Klaus, County Commissioner of Precinct No. 3 of Bexar County, Texas, all members present and voting "Aye" the said motion being carried unanimously, it was ordered by the Court that the revised bid of the H. N. Jones, Construction Company of \$200,092.00 with the change in plans as Addenda to the Original Plans and Specifications, as prepared by the Architects and presented to the Court on Thursday, August 26th, 1915, be accepted, and that the contract be awarded to the H.N. Jones, Construction Company for the construction of same and that the Honorable J.R. Davis, County Judge of Bexar County, Texas, for and in behalf of Bexar County, and the Honorable Clinton G. Brown, Mayor of the City of San Antonio, Texas, for and in behalf of the City of San Antonio, be and they are hereby authorized to enter into a contract with the H. N. Jones Construction Company for the construction of the Robert B. Green Memorial Hospital as per their revised bid and as per change in Plans and Addenda to the Original Plans and Specifications which are hereby accepted and adopted.

The Honorable J. R. Davis, County Judge of Bexar County, Texas, announced to the Court that Mr. Alexander Joske had offered to equip at a cost not exceeding Ten Thousand (\$10,000.00) Dollars the Operating Wing of the Robert B. Green Memorial Hospital, and upon the Motion of the Honorable Clinton G. Brown, Mayor of the City of San Antonio, seconded by the Honorable C. H. Kearny, City Commissioner, all members present and voting "Aye" the said motion being carried unanimously, it was ordered by the Court that the offer of Mr. Alexander Joske, be accepted, and that such operating wing of the Robert B. Green Memorial Hospital be designated as the "Alexander Joske Memorial" and that a plate be made with the suitable inscription and placed in same, and that a rising vote of thanks be extended to Mr. Alexander Joske for his generous offer.

The joint session then upon motion made and carried, adjourned.
