

AN ORDINANCE 2014 - 05 - 21 - 0361

CANVASSING THE MAY 10, 2014 SPECIAL ELECTION RESULTS.

* * * * *

WHEREAS, the Special Election was held on Saturday, May 10, 2014, to determine the District 9 Council Member of the City of San Antonio; and

WHEREAS, at the May 10, 2014 Election, the voters of City Council District 9 of the City of San Antonio were asked to elect a member of the City Council for Place 9, to be elected by a majority vote of the qualified electors voting in the election in that district; and

WHEREAS, the names of the candidates were submitted to the voters, the election was held and conducted and the returns were made, all as required by the City Charter and the laws of the State of Texas; and

WHEREAS, the City Council has reviewed and investigated all matters pertaining to the election, including the ordering, notices, election officers, holding and returns, and it is now necessary to declare the official results of the canvass; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council having convened on this 21st day of May, 2014, to canvass the returns of the Special Election held on May 10, 2014, and after canvassing the returns of this election, officially finds and determines that this election was duly ordered; proper notice of this election was given; proper election officers were duly appointed prior to this election; the election was duly held; the City has complied with the Federal Voting Rights Act, the Texas Election Code, and the City Charter; and due returns of the result of this election have been made and delivered, all in accordance with the law and the Ordinance calling the election.

SECTION 2. The City Council does officially find and declare the results of the Special Election to be as follows:




MEMBER OF COUNCIL, PLACE NO. 10:


