

AN ORDINANCE 2012-11-01-0847

DECLARING AS SURPLUS A 0.107 ACRE UNIMPROVED TRACT OF REAL PROPERTY LOCATED AT 16236 WHITE FAWN, NCB 14789, IN COUNCIL DISTRICT 8.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following property, held by the City of San Antonio for the use, benefit and control of the San Antonio Water System, is declared surplus to the needs of the City of San Antonio:

Arbitrary Parcel 100, Block 38, Hills and Dales Estates Subdivision, Unit 3, New City Block 14789, situated within the corporate limits of the City of San Antonio, Bexar County, Texas, as shown on the plat recorded in Volume 5140, Page 135, in the Plat Records of Bexar County, Texas.


SECTION 2. The President/CEO of the San Antonio Water System and his designee(s), severally, are authorized to do all things necessary or convenient to advertise the property for sale according to law, accept such bid as the San Antonio Water System may in its discretion accept (without requiring the San Antonio Water System to accept any bid), and effectuate transfer of the City's title to the property to the successful bidder.


SECTION 3. Funds generated by this ordinance will be for the use, benefit and account of the San Antonio Water System.

SECTION 4. This ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.
