

AN ORDINANCE 2012-03-01-0156

AMENDING THE CITY OF SAN ANTONIO MAJOR THOROUGHFARE PLAN, A COMPONENT OF THE CITY OF SAN ANTONIO MASTER PLAN TO DESIGNATE A SEGMENT OF 36TH STREET AS A SECONDARY ARTERIAL TYPE A (86 FEET RIGHT-OF-WAY), GENERALLY LOCATED WITHIN PORT SAN ANTONIO, SOUTH OF HIGHWAY 90 AND NORTH OF SW MILITARY DRIVE.

WHEREAS, the City of San Antonio Major Thoroughfare Plan was adopted on September 21, 1978 by City Council as a component of the City of San Antonio Master Plan; and

WHEREAS, a public hearing was held on January 25, 2012 by the Planning Commission allowing all interested citizens to be heard: **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1: The Major Thoroughfare Plan, a component of the Master Plan of the City, is hereby amended by designating a segment of 36th Street as a Secondary Arterial Type A (86' of right-of-way) generally located within Port San Antonio, south of Highway 90 and north of SW Military Drive. The Proposed Amendment to the Major Thoroughfare Plan as a component of the City of San Antonio Master Plan is more particularly described in **Attachment "I"** and **Attachment "II"**, attached hereto and incorporated herein for all purposes.

SECTION 2: This Ordinance shall take effect March 11, 2012.




