AN ORDINANCE

AUTHORIZING ISSUANCE OF A \$279,095 JOB ORDER TO DAVILA CONSTRUCTION FOR ROOF REPLACEMENT AND MISCELLANEOUS SKYLIGHT DEMOLITION TO THE INFORMATION TECHNOLOGY SYSTEM DEPARTMENT FACILITY, FUNDED THROUGH THE FY 2012 FACILITIES SERVICES FUND, LOCATED AT 515 SOUTH FRIO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee, severally, are authorized and directed to issue a \$279,095 job order to Davila Construction, Inc. for roof replacement and miscellaneous skylight demolition, the specific improvements and their specifications to be determined by the City Manager or her designee in the best interests of the City and the most efficient use of the affected space. The City Manager and her designee, severally, should take all actions necessary or convenient to effectuate the transaction, including executing and delivering all necessary or convenient instruments and agreements.

SECTION 2. Funding in the amount of \$279,095 for this ordinance is available in Fund 76001000, Cost Center 3506010002, General Ledger 5204050, as part of the Fiscal Year 2012 Budget.


SECTION 3. Payment not to exceed the budgeted amount is authorized and should be encumbered with a purchase order.


SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.




