

AN ORDINANCE 2008-01-31-0070

**APPROPRIATING FUNDS AND AUTHORIZING ADDITIONAL PROJECT CONTINGENCY IN THE AMOUNT OF \$71,911.00, IN CONNECTION WITH THE MAIN PLAZA REDEVELOPMENT PROJECT AND DOWNTOWN TRANSPORTATION INFRASTRUCTURE IMPROVEMENTS PROJECT, LOCATED IN DISTRICT 1 AND APPROPRIATING FUNDS.**

**WHEREAS**, this Ordinance appropriates funds in the amount of \$71,911.00 for project contingency in connection with the Main Plaza Redevelopment Project and Downtown Transportation Infrastructure Improvements Project; and

**WHEREAS**, the Main Plaza Redevelopment Project provides for the redevelopment of the Plaza de las Islas, the historical center of downtown, as a pedestrian plaza, being constructed in 2 phases - Phase I consists of drainage improvements, street improvements, and utility infrastructure and Phase II consist of improvements to landscaping and hardscaping; and

**WHEREAS**, approval of this Ordinance will be a continuation of Council policy to support the adopted Downtown Master Plan, the Downtown Neighborhood Plan, and the Historic Civic Center Master Plan, **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The amount of \$71,911.00 in connection with the Main Plaza Redevelopment Project and Downtown Transportation Infrastructure Improvements Project is hereby appropriated as follows:


- a) The amount of \$71,911.00 is appropriated in SAP Fund 43902025, 2007 CO Parks & Rec Improvements, SAP WBS CO-20750-01-01-09-02, SAP GL account 6102100 – Interfund Transfer out entitled Transfer to Trf To 23-00947-90-13. The amount of \$71,911.00 is authorized to be transferred to SAP Fund 40099000.
- b) The budget in SAP Fund 45099000, SAP Project Definition 23-00947, Main Plaza Redevelopment, shall be revised by increasing SAP WBS element 23-00947-90-13 entitled Trf Fr CO-20750-01-01-09-02, SAP GL account 6101100 – Interfund Transfer In, by the amount \$71,911.00.
- c) The amount of \$71,911.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-00947, Main Plaza Redevelopment, SAP WBS Element 23-00947-05-06, entitled Project Contingency, SAP GL Account 5201140, and is authorized to be encumbered for additional project contingency.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocation to specific SAP Fund

Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This ordinance shall be effective on the tenth day after passage.




