

AN ORDINANCE 52751

APPOINTING ANTONIO JIMENEZ, III, JUDGE OF THE MUNICIPAL COURT OF THE CITY OF SAN ANTONIO AND ASSIGNING HIM TO SERVE AS NIGHT MAGISTRATE AND SETTING HIS SALARY.

* * * * *

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Antonio Jimenez, III, is hereby appointed Judge of the Municipal Court of the City of San Antonio, Texas.

SECTION 2. Said Municipal Court Judge Antonio Jimenez, III, is hereby assigned to serve as Night Magistrate for the City of San Antonio.

SECTION 3. The duties of the said Night Magistrate shall be those prescribed by the laws of the State of Texas.

SECTION 4. Judge Jimenez' salary shall be at a rate of \$32,956.30 per annum, payable in 26 equal increments on the same days as other City employees are paid.

SECTION 5. A Municipal Court Judge is needed to act as Night Magistrate to insure the orderly processing of cases and the administration of justice in the Court, whose decisions affect the welfare of the citizens. Therefore, an emergency is hereby declared in the protection of the public welfare so that upon receipt of eight affirmative votes this ordinance shall become effective on September 5, 1980, but if this ordinance should pass with less than eight affirmative votes, it shall become effective on the eleventh day after passage hereof.
