

AN ORDINANCE 2011-06-17-0530

DESIGNATING EACH MEMBER OF THE CITY COUNCIL AS MAYOR PRO TEM FOR A SPECIFIED PERIOD DURING THE 2011-2013 TERM.

* * * * *

WHEREAS, Section 9 of the Charter of the City of San Antonio provides, in part, for a Mayor Pro Tem to act as Mayor during the absence or disability of the Mayor; and

WHEREAS, a tradition has been established of rotating the Mayor Pro Tem position among all of the members of the Council, other than the Mayor, during the two-year City Council term; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following named members of the City Council are designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:

June 17, 2011 through August 26, 2011	David Medina, Jr.
August 27, 2011 through November 5, 2011	Ray Lopez
November 6, 2011 through January 15, 2012	W. Reed Williams
January 16, 2012 through March 26, 2012	Jennifer V. Ramos
March 27, 2012 through June 5, 2012	Ivy R. Taylor
June 6, 2012 through August 16, 2012	Elisa Chan
August 17, 2012 through October 26, 2012	Rey Saldaña
October 27, 2012 through January 5, 2013	Diego Bernal
January 6, 2013 through March 17, 2013	Cris Medina
March 18, 2013 through May 31, 2013, or until such time as said City Councilmember's successor is elected and qualified for office.	Carlton Soules

SECTION 2. Councilmember David Medina, District 5, is sworn in as Mayor Pro Tem for the period beginning June 17, 2011 through August 26, 2011.


SECTION 3. Should a vacancy in the position of a Councilmember occur during the 2011-2013 Council term, the person appointed to fill the remainder of that vacant position shall assume the vacated Councilmember's designated term as Mayor Pro Tem.

SECTION 4. This Ordinance shall become effective immediately upon passage by eight affirmative votes; otherwise this ordinance shall take effect on the tenth day after passage.

PASSED AND APPROVED this 17th day of June 2011.






