

AN ORDINANCE 2009-03-05-0170

**APPROVING AN EXTENSION OF LINE-OF-DUTY  
INJURY LEAVE FOR SAN ANTONIO FIRE  
DEPARTMENT FIRE APPARATUS OPERATORS ROBERT  
FULLERTON, DONNIE NAPIER, AND LEA TWIDWELL.**

**WHEREAS**, section 143.073 of the Texas Local Government Code provides that a firefighter injured in the line of duty is entitled to line-of-duty injury leave with full pay for a period commensurate with the injury and not to exceed one year; and

**WHEREAS**, section 143.073 also provides that a municipality's governing body may extend the line-of-duty injury leave beyond one year; and

**WHEREAS**, San Antonio Fire Department Fire Apparatus Operator Robert Fullerton injured his back in the line of duty on September 30, 2006; and

**WHEREAS**, FAO Fullerton returned to full duty on May 20, 2008; and

**WHEREAS**, FAO Fullerton is requesting an extension of line-of-duty injury leave for the period October 1, 2007, to May 17, 2008; and

**WHEREAS**, approving the requested extension would provide 44 shifts (1056 hours) of personal and annual leave to FAO Fullerton; and

**WHEREAS**, San Antonio Fire Department Fire Apparatus Operator Donnie Napier injured his back in the line of duty on November 23, 2005; and

**WHEREAS**, FAO Napier has not yet returned to work; and

**WHEREAS**, FAO Napier is requesting an extension of line-of-duty injury leave for the period December 1, 2007, to February 2, 2009; and

**WHEREAS**, approving the requested extension would provide 133 shifts (3192 hours) of personal and annual leave to FAO Napier; and

**WHEREAS**, San Antonio Fire Department Fire Apparatus Operator Lea Twidwell injured her back in the line of duty on December 28, 2006; and

**WHEREAS**, FAO Twidwell returned to full duty on December 13, 2008; and

**WHEREAS**, FAO Twidwell is requesting an extension of line-of-duty injury leave for the period December 29, 2007, to December 13, 2008; and

**WHEREAS**, approving the requested extension would provide 76 shifts (1824 hours) of personal and annual leave to FAO Twidwell; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** An extension beyond one year of Fire Apparatus Operator Robert Fullerton's line-of-duty injury leave for the period October 1, 2007, to May 17, 2008, is hereby approved.

An extension beyond one year of Fire Apparatus Operator Donnie Napier's line-of-duty injury leave for the period December 1, 2007, to February 2, 2009, is hereby approved.


An extension beyond one year of Fire Apparatus Operator Lea Twidwell's line-of-duty injury leave for the period December 29, 2007, to December 13, 2008, is hereby approved.

**SECTION 2.** Potential funding sources for this ordinance include, but are not limited to, cost savings within the fund centers, adjustments to the year-end accrual for leave payable, and the closing ordinance. All expenditures will be in accordance with the current fiscal year budget approved by the City Council.

**SECTION 3.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

**SECTION 4.** This ordinance shall take effect ten days from the date of passage.


