

AN ORDINANCE **89489**

CREATING AN EARLY VOTING BALLOT BOARD TO  
PROCESS EARLY VOTING RESULTS FOR THE JOINT AND  
BOND ELECTION TO BE HELD ON MAY 1, 1999.

**WHEREAS**, Section 87.001, et. seq., Texas Election Code, requires that the governing body designate an Early Voting Ballot Board to process early voting ballots cast by personal appearance and by mail; and

**WHEREAS**, the Joint City and Bond Election has been set for May 1, 1999, with early voting balloting to be from April 14 - 27, 1999; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** In accordance with Section 87.001, et. seq., Texas Election Code, Marian Stanko is hereby appointed Presiding Judge of the Early Voting Ballot Board and Manuel Vara is appointed Alternate Judge of the Early Voting Ballot Board. The Early Voting Ballot Board shall consist of said presiding judge and at least two other members to be appointed by the presiding judge.

**SECTION 2.** That said Presiding Judge shall be authorized to hire a sufficient number of clerks to perform the duties necessary in canvassing the Early Voting Ballots.


**SECTION 3.** That the Early Voting Ballot Board Members shall be compensated at the rate of pay that presiding Election Judges receive as provided in Section 87.005, Texas Election Code. Said rate of pay is established by ordinance of the City Council of even date herewith.

**SECTION 4.** This ordinance shall be effective on and after the tenth day after passage hereof.

FINANCIAL IMPACT




