

AN ORDINANCE 2014 - 09 - 04 - 0659

**AUTHORIZING AN AMENDMENT TO THE PROFESSIONAL SERVICE AGREEMENT WITH ECONOMIC & PLANNING SYSTEM, INC. FOR PHASE I OF THE COMPREHENSIVE PLAN STUDIES BY EXTENDING THE TERM OF THE CONTRACT APPROVED BY CITY COUNCIL FROM AUGUST 31, 2014 TO DECEMBER 31, 2014.**

**WHEREAS**, on September 12, 2013 Ordinance No. 2013-09-12-0640 authorized the execution of a professional services agreement with Economic & Planning Systems, Inc., for comprehensive plan studies; and

**WHEREAS**, this ordinance amends the agreement with Economic & Planning Systems, Inc., and provides for extending the term of the agreement from August 31, 2014 to December 31, 2014; **NOW THEREFORE**,


**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** City Council hereby authorizes an amendment extending the term of the agreement from August 31, 2014 to December 31, 2014 for the professional services agreement between the City of San Antonio and Economic & Planning Systems, Inc., which was originally authorized by Ordinance 2013-09-12-0640, on September 12, 2013.


**SECTION 2.** A copy of the contract amendment is attached hereto as **Attachment I**.

**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT  
FOR COMPREHENSIVE PLAN STUDIES**

This amendment of the “Professional Services Agreement for Comprehensive Plan Studies” is entered into by and between the City of San Antonio (“City”) Economic & Planning Systems, Inc., (“Consultant”).

**WHEREAS**, City and Consultant entered into an agreement entitled “Professional Services Agreement for Comprehensive Plan Studies” (“Original Agreement”), pursuant to Ordinance No. 2013-09-12-0640 passed and approved on the 12th day of September , 2013 in which the Parties set forth their agreement for Consultant to conduct studies and to provide an analysis for developing an update to the City’s Comprehensive Plan; and

**WHEREAS**, the Original Agreement provided for a term beginning September 12, 2013 and ending August 31, 2014; and

**WHEREAS**, the Parties now wish to amend the Original Agreement to extend the term;

**NOW, IN ACCORDANCE THEREWITH**, the Parties agree as follows:

**I.       AMENDMENTS**

Article II, Section 2.1 of the Original Agreement is hereby amended to read as follows:

2.01 The term of this Agreement shall commence on September 12, 2013 and terminate on December 31, 2014.

**II.       PROVISIONS REMAIN IN EFFECT**

All other terms, conditions, covenants and provisions of the Original Contract, not specifically mentioned herein and revised by this document, are hereby retained in their entirety, unchanged, and shall remain in full force in effect for the duration of said Original Contract, and any renewals thereof.

**III.       ENTIRE AGREEMENT**

This agreement, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
