

AN ORDINANCE 77286

ORDERING THE REGULAR MUNICIPAL ELECTION TO BE HELD ON THE 1ST DAY OF MAY, 1993, IN THE CITY OF SAN ANTONIO, BEXAR COUNTY, TEXAS, FOR THE PURPOSE OF ELECTING THE MEMBERS OF THE COUNCIL OF THE CITY OF SAN ANTONIO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. That the regular municipal election be, and the same is ordered hereby to be held on Saturday, the 1st day of May, A.D., 1993, in accordance with the laws of Texas and the provisions of the Charter of the City of San Antonio, and the official ballots for said election shall be prepared in accordance with the Texas Election Code for the election of the following municipal officers, to-wit:

Ten members of the Council, Place 1 through Place 10, being one each to be elected from districts or wards numbered accordingly (all as provided by Section 4 of the City Charter), each for a term of two years beginning on the first day of June, 1993 and One member to be elected as Mayor, Place 11, by a majority of all qualified voters voting in said election as provided in Sections 4 and 9 of the City Charter.

SECTION 2. That at said election shall be held as prescribed by law, in the City of San Antonio at the following polling or voting places in the several precincts of the City of San Antonio between the hours of 7:00 o'clock A.M. and 7:00 o'clock P.M.:




SECTION 3. Voting at said election shall be done by the use of voting machines, paper ballots or the electronic voting system as determined by the City Clerk, and the City Council of the City of San Antonio does determine hereby that voting machines, paper ballots or electronic voting system shall be used for the casting of early votes at this election, shall be placed at branch offices (Attachment II) established for the purpose of conducting early voting by personal appearance. The City Clerk, or Assistant City Clerk is authorized and charged to perform the functions provided by law in the casting of early ballots and shall hold such election, and ballots shall be cast commencing April 12, 1993 and ending April 27, 1993; all in the method, manner and time made and provided by the Statutes of the State of Texas on this subject.


SECTION 4. The Mayor and City Council shall appoint the election officers to hold said election, in accordance with law, including an Early Voting Ballot Board which shall count and canvass the early ballots cast at said election.

SECTION 5: Notice of said election shall be given by publishing a substantial copy of this ordinance in a daily newspaper of general circulation published in the City, not less than 30 days before the date of the election.




