

AN ORDINANCE **86033**

AMENDING ORDINANCE NO. 85964 OF MAY 8, 1997, WHICH ADOPTED POLLING LOCATIONS FOR THE MAY 27, 1997, RUNOFF ELECTION, BY RECOMBINING PRECINCT 3139 WITH PRECINCT 2077, VOTING AT JIMMY ELROD ELEMENTARY, 8885 HEATH CIRCLE; AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE UPON PASSAGE OF EIGHT AFFIRMATIVE VOTES.

WHEREAS, Ordinance No. 85964 passed and approved on May 8, 1997, adopted polling places for the May 27, 1997, City Council Runoff Election; and

WHEREAS, said ordinance provided that Precinct 3139 was combined with Precinct 3176 at John Marshall High School; and

WHEREAS, such polling location is located outside of the City limits of the City of San Antonio and within the City limits of the City of Leon Valley; and

WHEREAS, it is now necessary to recombine Precinct 3139 with Precinct 2077, voting at Jimmy Elrod Elementary, 8885 Heath Circle, a location within the City limits of San Antonio and to provide for immediate effect for this amendment to Ordinance No. 85964 in order to accommodate Early Voting as of May 19, 1997; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinance No. 85964 passed and approved on May 8, 1997, is amended to recombine Precinct 3139 with Precinct 2077, voting at Jimmy Elrod Elementary, 8885 Heath Circle within the City limits of the City of San Antonio.

SECTION 2. In order that this amendment to Ordinance No. 85964 may be submitted to the U.S. Department of Justice for clearance under the Voting Rights Act, an emergency is hereby declared so that this ordinance shall take effect immediately upon passage by eight (8) affirmative votes, otherwise this ordinance shall take effect on the tenth day after passage hereof, in preservation of the public health, safety and welfare.



FINANCIAL IMPACT:


No extra costs to the Elections Budget due to the combination of this precinct with an existing polling site.


POLICY IMPLICATIONS:
