**SCHEDULING SPECIAL CITY COUNCIL MEETINGS IN JUNE, AUGUST,  
AND SEPTEMBER 2011; AND RESCHEDULING TWO JUNE AND ALL  
JULY 2011 CITY COUNCIL-RELATED MEETINGS.**

**WHEREAS**, due to the need for the City Council to meet to set goals and plan the FY 2012 budget, it is necessary to schedule special City Council meetings, and to reschedule two regularly scheduled June and all July City Council and Council Committee meetings; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Special City Council Meetings are scheduled as follows:







