

**AN ORDINANCE**

**DESIGNATING EACH MEMBER OF THE CITY COUNCIL AS MAYOR PRO TEM FOR A SPECIFIED PERIOD DURING THE 2009-2011 TERM.**

**WHEREAS**, Section 9 of the Charter of the City of San Antonio provides, in part, for a Mayor Pro Tem to act as Mayor during the absence or disability of the Mayor; and

**WHEREAS**, a tradition has been established of rotating the Mayor Pro Tem position among all of the members of the Council, other than the Mayor, during the two-year City Council term; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The following named members of the City Council are designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:

June 19, 2009 through August 28, 2009	Mary Alice P. Cisneros
August 29, 2009 through November 7, 2009	David Medina, Jr.
November 8, 2009 through January 17, 2010	Philip A. Cortez
January 18, 2010 through March 29, 2010	Elisa Chan
March 30, 2010 through June 8, 2010	John G. Clamp
June 9, 2010 through August 18, 2010	Justin Rodriguez
August 19, 2010 through October 28, 2010	Jennifer V. Ramos
October 29, 2010 through January 7, 2011	Ivy R. Taylor
January 8, 2011 through March 19, 2011	W. Reed Williams
March 20, 2011 through May 31, 2011, or until such time as said City Councilmember's successor is elected and qualified for office.	Ray Lopez

**SECTION 2.** Councilmember Mary Alice P. Cisneros, District 1, is sworn in as Mayor Pro Tem for the period beginning June 19, 2009 through August 28, 2009.

**SECTION 3.** Should a vacancy in the position of a Councilmember occur during the 2009-2011 Council term, the person appointed to fill the remainder of that vacant position shall assume the vacated Councilmember's designated term as Mayor Pro Tem.

**SECTION 4.** This Ordinance shall become effective immediately upon passage by eight




affirmative votes; otherwise this ordinance shall take effect on the tenth day after passage.
