

AN ORDINANCE **94073**

**DESIGNATING CERTAIN MEMBERS OF THE 2001-2003 CITY COUNCIL AS MAYOR PRO TEM FOR SPECIFIED PERIODS OF TIME THROUGH MAY 31, 2003; AND SWEARING IN OF MAYOR PRO TEM FOR THE PERIOD JUNE 7, 2001 THROUGH AUGUST 20, 2001, AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE UPON PASSAGE OF EIGHT (8) AFFIRMATIVE VOTES.**

**WHEREAS**, the City Charter in Section 9 calls for a Mayor Pro Tem to act as Mayor during the absence or disability of the Mayor; and

**WHEREAS**, a tradition has been established of retaining the Mayor Pro Tem position among all of the members of the Council other than the Mayor during each two year term;  
**NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The following named members of the City Council are hereby designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:




**SECTION 2.** Should any of the above Council Members be replaced for any reason, such replacement shall be substituted for such member for the term indicated.
