AN ORDINANCE **5 739 6**

APPOINTING MS. FRANKIE BOYD, AND MRS. LETICIA LUNA  
AS MUNICIPAL COURT JUDGES; AND APPOINTING  
MR. RONALD B. PRINCE AS A PART-TIME MUNICIPAL  
COURT JUDGE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ms. Frankie Boyd is hereby appointed as a Municipal Court Judge. Judge Boyd's salary shall be at a rate of \$38,526.75 per annum, payable in twenty-six equal increments on the same days as other City employees are paid. This appointment will be effective September 1, 1983. The current City of San Antonio pay plan is hereby revised to reflect the above salary provision.

SECTION 2. Ms. Leticia Luna is hereby appointed as a Municipal Court Judge. Judge Luna's salary shall be at a rate of \$38,526.75 per annum payable in twenty-six equal increments on the same days as other City employees are paid. This appointment will be effective October 1, 1983. The current City of San Antonio pay plan is hereby revised to reflect the above salary provision.

SECTION 3. Mr. Ronald B. Prince is hereby appointed as a part-time Municipal Court Judge. Judge Prince's salary shall be at a rate of \$18.52 per hour for the time actually served (part-time night Magistrate). This appointment will be effective August 12, 1983. The current City of San Antonio pay plan is hereby revised to reflect the above salary provision.
