

AN ORDINANCE **60575**

AMENDING ORDINANCE NO. 60511 (CANVASS OF REGULAR ELECTION) BY CORRECTING DISCREPANCIES OF THE PRESIDING JUDGES' RETURN SHEETS FOUND IN A RECHECK OF VOTING MACHINES IN PRECINCT 1050 AND PRECINCT 3061.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. That Ordinance No. 60511 of April 8, 1985, is hereby amended so as to correct certain discrepancies of the presiding judges' return sheets found in a recheck of the voting machines used for the regular City election held on April 6, 1985.

FOR MEMBER OF COUNCIL, PLACE NO. 10:

ADD: 336 votes for James C. Hasslocher

SUBTRACT: 336 votes from Cyle Cochran

FOR MEMBER OF COUNCIL, PLACE NO. 11 (MAYOR):

ADD: 100 votes for Henry G. Cisneros

SECTION 2. The above corrections are necessary because of errors in the original return sheets which were found in a recheck of the voting machines. The above change affecting Council Place No. 10 is a result of a recheck of the votes cast in Precinct 3061 and the above change in Council Place No. 11 (Mayor) is a result of a recheck of votes cast in Precinct 1050.




