APPOINTING A REPLACEMENT TO FILL THE UNEXPIRED
TERM OF COUNCILMAN RICK VASQUEZ, AND PROVIDING
FOR AN IMMEDIATE EFFECTIVE DATE UPON THE
PASSAGE OF EIGHT AFFIRMATIVE VOTES.

WHEREAS, Councilman Rick Vasquez, District 5 representative on the City Council, has submitted his resignation which has been accepted by the City Council; and

WHEREAS, pursuant to City Charter, Section 8, a vacancy on the Council is to be filled by a majority vote of the remaining members for the unexpired term; and

WHEREAS, the City Council invited the qualified residents of District 5 to submit letters of interest and resumes to the City Clerk for consideration in being appointed to fill the vacancy created on this Council by the resignation of Councilman Rick Vasquez; and

WHEREAS, the City Council interviewed seven applicants on March 16, 2000, those being: David Andrew Garcia, Gilbert Gallego, II, Lourdes B. Rodriguez, Aaron J. Seaman, Oscar R. Garza, Robert T. Arocha, and Shirley A. Aguilar; and

WHEREAS, two applicants, Robert T. Arocha and Shirley A. Aguilar have withdrawn their names from consideration; and

WHEREAS, the City Council has reviewed the nomination of the following: David Andrew Garcia, Gilbert Gallego, II, Lourdes B. Rodriguez, Aaron J. Seaman, and Oscar R. Garza, and

WHEREAS, the City Council of the City of San Antonio now wishes to appoint a replacement to fill the unexpired City Council term of Rick Vasquez, District 5;

NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. David Andrew Garcia is hereby appointed as a member of the City Council, Place No. 5, to serve for the remainder of the unexpired term of Rick Vasquez.

SECTION 2. Because the citizens of District 5 should not be without representation on the City Council, an emergency is hereby declared so that this ordinance and the appointment made hereby shall be effective immediately upon the affirmative vote of at least eight members of the Council; otherwise, this ordinance shall take effect on the tenth day after passage hereof.





SUMMARY:

This Ordinance will provide for the appointment of a replacement to fill the unexpired term of Councilman Rick Vasquez, who resigned effective March 3, 2000. Following interviews at the City Council meeting of March 16, 2000, it was directed by Council motion to move all five nominees to the City Council agenda of March 23, 2000.

BACKGROUND:

Following direction of City Council subsequent to Councilman Vasquez's announced resignation as City Council member, District 5 applications from qualified candidates were sought from the District 5 community. A total of seven persons submitted qualified applications, and were interviewed by City Council at its March 16, 2000 meeting. Two applicants withdrew their applications. It was then directed that the names of the remaining five qualified applicants be brought forward to the City Council meeting of March 16, 2000 as nominees to fill that vacant City Council position.


