

AN ORDINANCE 2014-10-16-0797

RESCHEDULING CITY COUNCIL MEETINGS IN NOVEMBER AND DECEMBER 2014, AND JANUARY 2015; AND SCHEDULING A SPECIAL COUNCIL MEETING FOR NOVEMBER 18, 2014 TO CONDUCT OFFICIAL CITY BUSINESS PRIOR TO THE NATIONAL LEAGUE OF CITIES CONFERENCE.



SECTION 4. All Council Committee meetings previously scheduled for the four weeks above may be rescheduled to the corresponding weeks, as noted in this chart.


SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise it is effective on the tenth day after passage.


