

AN ORDINANCE **86102**

APPOINTING ALFREDO M. TAVERA AS A FULL-TIME MUNICIPAL COURT JUDGE FOR A TERM OF OFFICE TO EXPIRE ON AUGUST 31, 1997; AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE UPON PASSAGE OF EIGHT AFFIRMATIVE VOTES; AS REQUESTED BY COUNCILMAN ROGER FLORES, II.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

The Municipal Court Committee interviewed applicants for the position of Municipal Court Judge on May 9, 1997. After careful review of all applications, the Committee recommends and the City Council hereby appoints Alfredo M. Tavera to serve a full-time Municipal Court Judge with a term that will expire on August 31, 1997. Due to Mr. Tavera's appointment as a Municipal Court Judge effective date of June 1, 1997, this ordinance shall take effect immediately upon passage of eight affirmative votes.




ROGER FLORES II, DISTRICT 1






