AUTHORIZING ESTABLISHMENT OF TEMPORARY BRANCH OFFICES FOR CONDUCTING ABSENTEE VOTING BY PERSONAL APPEARANCE FOR THE RUN-OFF CITY ELECTION TO BE HELD ON APRIL 18, 1981.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The establishment of temporary branch offices for conducting absentee voting by personal appearance for the Run-off Election to be held April 18, 1981, is hereby authorized, as provided in Article 5.05, Subdivision 14(b) of the Texas Election Code, at the following locations.

- a. City Hall
- b. Windsor Park Mall

SECTION 2. The City Clerk is hereby authorized to maintain the aforementioned two (2) temporary branch offices for absentee voting by personal appearance and shall station one or more deputies at each branch office to conduct the voting. Said branch offices shall be kept open during the regular working hours for the Clerk at her main office.
