

AN ORDINANCE **85644**

AMENDING ATTACHMENT I OF ORDINANCE NO. 85569, PASSED AND APPROVED ON FEBRUARY 6, 1997, SO AS TO RECOMBINE POLLING LOCATIONS FOR PRECINCTS 3118 AND 3180 WITH THE POLLING LOCATION FOR PRECINCT 3051 AT 8900 STARCREST DUE TO VOTER REQUEST; AS REQUESTED BY COUNCILMAN JEFF WEBSTER.






