

AN ORDINANCE 2012-06-07-0408

AWARDING A CITY COUNCIL PROJECT FUNDS ALLOCATION TO THE MARTIN LUTHER KING, JR. SCHOLARSHIP FUND IN AN AMOUNT UP TO \$13,700.00.

WHEREAS, the adopted FY 2012 Budget provided for individual City Council district discretionary funds for programs, activities, events, scholarships, goods or services that promote specified municipal public purposes set out in guidelines approved by City Council pursuant to Ordinance 2011-12-08-1011 approved on December 8, 2011; and

WHEREAS, The “Martin Luther King, Jr. Memorial City-County Commission,” now referred to as the “San Antonio Martin Luther King, Jr. Commission” or “MLK Commission,” was established on April 3, 1986 by City Council pursuant to Resolution No. 86-15-19 and is a volunteer organization that supports improving the quality of education for all of the youth in San Antonio; and

WHEREAS, the Commission awards scholarships to Bexar County high school graduates that plan to pursue a degree or certification at any two or four year accredited college, university, vocational or technical school; and

WHEREAS, the MLK Scholarship is eligible for funding under the City Council Project Fund Guidelines and it is the desire of the Mayor and each Councilmember to support this Scholarship Fund; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. A City Council Project Fund grant allocation to the MLK Commission in the amount of \$13,700.00 for the MLK Scholarship Fund is hereby approved.

SECTION 2. Funding in the amount of \$13,700.00 for this Ordinance is available in Fund 11001000 per the table below, as part of the Fiscal Year 2012 Budget.

SECTION 3. Funds generated by this Ordinance will be deposited into Fund 29603014, Internal Order 205000000001 and General Ledger 4502220.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.




