AN ORDINANCE **35721**

AUTHORIZING PAYMENT OF \$83,306.66 OUT OF THE GENERAL FUND TO THE URBAN RENEWAL AGENCY FOR A ONE-YEAR LEASE OF 59.1887 ACRES OF LAND LOCATED IN THE CIVIC CENTER PROJECT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. That payment of \$83,306.11 is hereby authorized out of the General Fund, Special Projects Account 21-05-03, to the Urban Renewal Agency of the City of San Antonio in payment for a one-year lease of 59.1887 acres of land located in the Civic Center Project Tex R-83 for the period of August 1, 1967, through July 31, 1968, in accordance with the terms of an agreement executed on August 13, 1966, and authorized by Ordinance No. 34898 passed and approved by the City Council on the same date.
