**A REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF SAN ANTONIO
WAS HELD IN THE COUNCIL CHAMBERS, MUNICIPAL PLAZA BUILDING,
WEDNESDAY, FEBRUARY 14, 2007 AND
THURSDAY, FEBRUARY 15, 2007**

The City Council convened in an informal "B" Session at 3:00 pm, Wednesday, February 14, 2007 in the Council Chambers, Municipal Plaza Building, with the following Councilmembers present: Flores, McNeil, Gutierrez, Perez, Radle, Herrera, Guajardo, Hall, Wolff, Haass, and Mayor Hardberger.

1) Discussions, deliberations and possible actions by the City Council regarding all aspects of the 2007-2012 General Obligation Bond Program, including determination of projects to be included in the Program.

City Manager Sculley gave an update on the 2007-2012 Bond Program. The informational package presented denoted the distribution for funds for each bond project, a listing of street, bridge, and sidewalk improvements, as well as a copy of the proposed Bond Ordinance reflecting the ballot language.

The information provided by Ms. Sculley is on file with the Office of the City Clerk.

Ms. Sculley also spoke on the Five-Year Park Facility Renovation Program. She stated that the Program called for the funding of \$1 million annually for Park Improvements.

At this this time, Mayor Hardberger recessed the meeting at 3:15 pm to convene in Executive Session for the purpose of:

A. Discuss legal issues related to the 2007-2012 General Obligation Bond Program pursuant to Texas Government Code Section 551.071 (consultation with attorney).

Mayor Hardberger reconvened the meeting at 4:01 pm.

Ms. Sculley requested councilmembers provide her with any comments and/or changes as soon as possible in order for the changes to be reflected in the Bond Ordinance which is scheduled to be called on Thursday, February 15, 2007.

The "B" Session adjourned at 4:15 pm.

The San Antonio City Council convened in the Council Chambers, Municipal Plaza Building in a Regular Council Meeting on Thursday, February 15, 2007 at 9:00 am.

City Clerk Leticia M. Vacek took the Roll Call and noted a quorum was present with the following Councilmembers: Flores, McNeil, Gutierrez, Perez, Radle, Herrera, Guajardo, Hall, Wolff, Haass, and Mayor Hardberger.

The Invocation was delivered by Reverend Kevin Love, Assistant to the Pastor, Macedonia Missionary Baptist Church, Guest of Councilmember Delicia Herrera.

Mayor Hardberger led the Pledge of Allegiance to the Flag of the United States.

MINUTES

Councilmember Perez made a motion to approve the minutes of the February 1, 2007 City Council Meeting. Councilmember Guajardo seconded the motion.

The motion prevailed by the following vote: AYES: Flores, McNeil, Gutierrez, Perez, Radle, Herrera, Guajardo, Hall, Wolff, Haass, and Mayor Hardberger. NAY: None. ABSENT: None.

ITEMS FOR INDIVIDUAL CONSIDERATION

The City Clerk read the following Ordinance:

2007-02-15-0154

Item 4. AN ORDINANCE ADOPTING A FIVE-YEAR PARKS MAINTENANCE AND RENOVATION PROGRAM TO IDENTIFY AND PRIORITIZE PROJECTS, PRIORITIZE RENOVATION ACTIVITIES, PROPOSE BUDGETS FOR EACH PROJECT, AND OUTLINE THE YEAR OF COMPLETION OF EACH PROJECT.

Councilmember Perez made a motion to approve the proposed Ordinance. Councilmember McNeil seconded the motion.

Ms. Sculley made a presentation which covered both Items 4 and 5. Councilmembers were presented with a listing of Park Improvements that would be undertaken as part of the Five-Year Maintenance Program. She stated that funding in the amount of \$1 million for Park Improvements would part of the Annual Operating Budget.

Also presented was an informational package that listed street, bridge, and sidewalk improvements by proposition, as well as a copy of the Bond ordinance reflecting the ballot language.

Ms. Sculley commented that 1999 Bond Projects would be substantially complete by December.

She continued by stating that this Bond Package is one of several be presented to the voters for approval. Ms. Sculley envisioned presenting a \$300 million Bond Package to the voters in 5 years with another \$300 million Bond Package being presented 5 years after that.

Ms. Sculley stated that if passed, the City would repay annually \$110 million for a total of 5 years. All 151 projects are expected to be completed in 5 years.

The following citizen(s) appeared to speak:

Mr. Bob Martin, President, Homeowners Taxpayer Association, addressed the Council with regards to the negative financial impact the Bond Program would have on the community if it was passed.

Ms. Mary Kathryn Luna addressed the Council with regards to the petition submitted by the Rainbow Hills Area Neighborhood Association. The petition requested that the \$400,000 that was originally allocated to build a new gymnasium at the Jean Yates Community Center be restored. She noted that the after-school program at the Community Center and Park averages 40 to 50 children a day. Ms. Luna continued by stating that in 1996 a petition with 649 signatures was submitted. The petition requested the City build a Community Center and various recreational facilities at the Jean Yates Park.

Mr. Fred Magee, President, Rainbow Hills Area Neighborhood Association, also addressed the Council relating to the funding information provided regarding the Jean Yates Community Center. He commented on the fact that funding for the center had changed several times since the information was originally presented.

Mr. Jerry Smith, President of the Shavano Ridge Homeowners Association, addressed the Council with regards to the change in funding in the amount of \$11 million for the DeZavala Road Expansion Project. Based on staff recommendations, the money for said project was reallocated. Mr. Smith stated that a traffic study was not completed prior to the removal of the project from the Bond Program and that area residents would be affected by the change.

Mr. Nelson Lopez of the San Antonio Hispanic Chamber of Commerce spoke in favor of the method that was exercised in identifying bond projects. Mr. Lopez noted that the approach was a good one and encouraged the Council to embrace the recommendations made by the various committees. He suggested that in the future more time be allowed for citizen input. Mr. Lopez requested that the Council inform the public on the progress of the bond projects once they commenced.

Mr. Jack M. Finger, P.O. Box 12048, addressed the Council relating to the Bond and Parks Maintenance Programs. He asked when the approved bond proposals would be completed since projects from the 1999 Bond Program took 8 years to complete. He noted that one other project from a previous Bond Program took 18 years to complete.

Ms. Carol Abitz of the Southwest Community Association addressed the Council relating to the change in funding for Pearsall Park Improvements. She recommended that the Council include Pearsall Park in its Park Maintenance Program due to the fact that it is the 5th Largest Park in the City.

Ms. Brenda Vickery Johnson, 2007 Chairman of the Greater San Antonio Chamber of Commerce, congratulated the Council for its holistic approach in identifying the 2007 Bond Projects. She also commended the process which allowed for citizens to make recommendations as well as be involved in the decision-making. She stated that the Chamber supported projects that allowed the City to increase public safety and enhance the quality of life. Ms. Johnson commented that the needs of the community are much greater than what can be funded in the

current bond proposal. She stated that the Chamber was appreciative of the Council identifying such bond projects as priorities: the purchase of the Voelcker Ranch, the development of Soccer Fields, the expansion of the Witte Museum, and funding of UTSA. Ms. Johnson stated that great cities must invest in themselves.

City Clerk Leticia M. Vacek made a presentation highlighting key dates for the May 12, 2007 General Election. Ms. Vacek informed Council of the election procedures to be utilized as well

as presented them with a copy of the Early Voting and Election Day sites. She stated that for this election a total of 39 Early Voting sites would be utilized. Typically, the City utilizes 21 Early Voting sites. This increase was due to the fact that several local entities will be joining the City of San Antonio on the May 12, 2007 ballot.

The power point presentation made by Ms. Vacek is on file with the Office of the City Clerk.

The following citizen(s) appeared to speak:

Mr. Jack Finger, P.O. Box 12048, addressed the Council in regards to Items 7, 8, 10, 11, 15, 17, 18, 20, 28, and 30. For Item 26, he asked why the City was funding therapeutic dance classes. As it relates to Item 7, Mr. Finger commented on the City purchasing electrolyte replacement drink mixes for workers. For Item 9, he stated that the City was promoting gambling by selling confiscated eight-liners. Mr. Finger stated that the agenda contained an error for Item 10 – it should read Loop 1604 and not Loop 410. For Item 20, he stated that a survey was going to be conducted to determine condom usage in the prevention of HIV/AIDS. Lastly, Mr. Finger noted that several Councilmembers had conflicts of interest related to Item 15.

City Clerk Leticia M. Vacek read a written testimony submitted by Faris Hodge, Jr., 140 Dora, relating to Item 34. Mr. Hodge wrote in favor of the City disannexing Timberwood Park because the City needs to take care of what it currently has within the City limits. He noted the shortage of police and fire personnel as well as code enforcement officers.

CEREMONIAL ITEMS

1. Mayor Hardberger read and presented a Certificate of Congratulations to Chief Robert Ojeda who will retire from the City of San Antonio after 33 years of dedicated service. Chief Ojeda joined the Fire Department in 1973 and has served as Chief since 1993.
2. Mayor Hardberger also presented a Certificate of Appreciation to the U.S. Olympic Committee in partnering with the San Antonio Sports Foundation creating the Community Olympic Development Program. The program offers training in 3 designated Olympic Sports – badminton, fencing and driving.

Mayor Hardberger excused himself from the meeting at this time. Councilmember Haass presided.

CITIZENS TO BE HEARD

The following citizen(s) appeared to speak:

Mr. Nazarite Ruben Flores Perez, 627 Hearne, addressed the Council and spoke on racism and religion.

Mr. Mark Perez, 119 Hardman, addressed the Council and stated that he was still awaiting a response from Environmental Services and Development Services regarding a facility that has been contaminating the environment with flammable chemicals. He also spoke in regards to Mission Petroleum Carriers operating without a certificate of occupancy.

Mr. Joe Fox, addressed the Council and presented examples of how the Bush Administration was in violation of the Declaration of Independence.

Mr. Faris Hodge, Jr., 140 Dora, addressed the Council and spoke on several issues. Such issues included the cost of getting married on the Riverwalk increasing, Councilmembers not having any Black staff members, the City being in violation of Affirmative Action policies, the CPS Energy Board not soliciting applications for Board members, the City not scheduling public hearings at more convenient times, and the Citizens to be Heard portion of City Council Meetings not being aired. Lastly, he noted the racial profiling being conducted by the Police Department.

Mr. Zaragosa, 1607 N.W. 26th St., addressed the Council and spoke about the defects in his SAHA home. Such defects include foundation issues, soil erosion, as well as health and safety issues.

Mayor Pro Tem Chip Haass excused himself from the meeting at the time. Councilmember Herrera presided.

Mr. George Alejos, LULAC, spoke on the behalf of Margarito and Yolanda Zuniga. He stated that SAHA was retaliating against the Zuniga Family simply for requesting adequate heat. Mr. Alejos stated that the property manager had Mr. and Mrs. Zuniga arrested and charged with intoxication. The Zuniga Children are under the care of Child Protective Services and the family was being evicted from their home. Mr. Alejos requested that the City Council investigate SAHA for intimidation.

Mayor Pro Tem Haass returned to the meeting at this time and presided.

Ms. Cirila Lozano, Ms. Amelia Fuentes, and Ms. Sandra Fuentes, residents of Mirasol Homes, addressed the Council and presented the problems they have had with their homes. Such issues include threats of eviction for a Chain Link fence (which had been up for over 3 years), not having cold water, and having a water leak for a year. The group requested that the City Council investigate SAHA.

Mr. Ed O'Campo, addressed the Council on behalf of residents of the Villa De Fortuna Subdivision. He stated that landscapers went to his home on February 15th to lay clay to protect the foundation. Previously, SAHA informed residents to water the foundation to their home in order to protect the foundation. Mr. O'Campo continued by commenting on issues his neighbor's had with their home. Such issues included homes being infected with flies and plumbing issues. The group requested that the City dissolve SAHA.

Ms. Cynthia Ynman, resident of Villa De Fortuna, addressed the Council and requested that the City Council investigate SAHA.

Mr. Bill Martinez, 1022 Arbor Place, addressed the Council and commented that the concerns presented by the homeowners are serious and need to be addressed immediately. He requested that KB Homes and SAHA do the right thing by helping out the homeowners.

Mr. Arthur Hernandez, a District 5 resident, addressed the Council and commented how councilmembers need to educate the public and develop programs on such issues as child care and financial management.

Mr. Charles Escobar, Foxbrough resident, addressed the Council and stated that KB Homes have design flaws. He commented that he was deceived by KB Homes and that disclaimer forms were not provided to him when he purchased his home.
