

AN ORDINANCE 2014 - 05 - 15 - 0335

**AUTHORIZING THE ACCEPTANCE OF ADDITIONAL FUNDS IN THE AMOUNT OF \$285,876.23 FROM THE FEDERAL HIGHWAY ADMINISTRATION FOR THE CITY'S TRAFFIC SIGNAL SYSTEM.**

**WHEREAS**, through Ordinance No. 2008-03-06-0166 the City of San Antonio entered into an agreement with the Texas Department of Transportation (TxDOT) to administer a High Priority Project funded through the Federal Highway Administration (FHWA) and accept funds in the amount of \$2,847,360.00; and

**WHEREAS**, of the \$2,847,360.00, the Federal Highway Administration was to reimburse the City 80% (\$2,277,888.00) and the City's match was 20% (\$569,472.00) funded from Advanced Transportation District (ATD) funds which were utilized to implement a portion of the Traffic Signal Coordination component of the Traffic Signal Synchronization/Modernization (TSSM) Project; and

**WHEREAS**, the City has been notified by TxDOT that the Federal Highway Administration is indicating that there is an additional \$285,876.23 in funds available to the City for this High Priority Project (Traffic Signal Coordination) that previously was approved and completed

**WHEREAS**, this Ordinance authorizes the City to accept the additional FHWA funds which will be placed into the TSSM Project so that the funds may be utilized to continue completing upgrades to the existing system that may include radar, traffic monitoring cameras, speed sensors, or travel sensors which will enhance traffic flow monitoring capabilities; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee, or the Director of the Public Works Department or his designee is hereby authorized to accept grant funds in an amount up to \$285,876.23 from the Federal Highway Administration to fund potential upgrades of the Traffic Signal System Modernization/Synchronization Program. The Texas Department of Transportation will administer these funds. A copy of said application is on file with the Department of Public Works.

**SECTION 2.** The City Manager or her designee is further authorized to execute any and all necessary documents to effectuate said application and acceptance.

**SECTION 3.** The following financial adjustments are hereby approved:

- a) Fund 2605923003 entitled "FHWA Grant" is hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant and the sum of up to \$285,876.23.00 from the FHWA will be appropriated in said fund.

- b) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


