WHEREAS, Section 7 of Article 1269 1-3, Vernon's Texas Civil Statutes, provides that proposed Urban Renewal Plans and proposed modifications to said plans shall be approved by the City Council of the City, and

WHEREAS, the Planning Commission and the Urban Renewal Agency of the City of San Antonio have reviewed proposed Amendment No. 7 to the Urban Renewal Plan for the Civic Center Project, Tex. R-83 and made favorable recommendations; NOW THEREFORE,

BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SAN ANTONIO:

THE City Council of the City of San Antonio hereby approves Amendment No. 7 to the Urban Renewal Plan for the Civic Center Project, Tex. R-83, modifying Paragraph II, Land Use Plan, Sub-paragraph B, Land Use Provisions and Building Requirements, I (a) Public Use Area of the Urban Renewal Plan, to read as follows:

"Public uses include those uses necessary and related to the development and operation of a civic center and municipal complex; greenbelts, neighborhood parks, and other open space uses in conformance with the City of San Antonio's Parks Master Plan; public neighborhood parking facilities; hotels and incidental uses thereto."
