

AN ORDINANCE 2008-05-15-0406

AUTHORIZING A SECTION OF ASHLEY ROAD TO BE RENAMED ACEQUIA ROAD BETWEEN MISSION ROAD AND ASHLEY ROAD AND AUTHORIZING A SECTION OF ASHLEY ROAD TO BE RENAMED MISSION ROAD BETWEEN MISSION ROAD AND VILLAMAIN STREET.

**WHEREAS:** There are currently three sections of Ashley Road intersecting each other;

**WHEREAS:** The first section runs between the intersection of Mission Road and Ashley Road and the intersection of Ashley Road and Villamain Street;

**WHEREAS:** The second section runs between the intersection of Mission Road and Ashley Road and the intersection of Ashley Road and Ashley Road;

**WHEREAS:** The third section runs between the intersection of Roosevelt Road and Ashley Road and the intersection of Ashley Road and Espada Road;

**WHEREAS:** In order to avoid confusion and address a significant public safety concern, the City wishes to rename sections one and two of Ashley Road. **NOW THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The first section of Ashley Road that is between Mission Road and Villamain Street is hereby renamed Mission Road.


**SECTION 2.** The second section of Ashley Road that is between Mission Road and Ashley Road is hereby renamed Acequia Road.

**SECTION 3.** City staff is directed to provide appropriate signage to this effect.

**SECTION 5.** This Ordinance shall be effective on 25<sup>th</sup> day of May, 2008.


